The **Aims** of this course and study days are for delegates to:

Develop understanding in Patient Assessment, evidence-based and patient-centred Treatment Planning for advanced restorative dentistry involving dental implants. Develop knowledge in patient-communication, patient-education and to demonstrate their ability to effectively gain appropriate consent for implant dentistry.

Develop and demonstrate to an appropriate level, the skills and knowledge necessary in the safe placement and restoration of implants.

## **Learning outcomes**

By the end of this certificate course, participants should be able to:

- 1. Clinically assess a patient's suitability for advanced restorative dentistry involving implants, by undertaking a risk-benefit analysis, to identify any physical or medical health issues that could make the patient unsuitable for implant surgery.
- 2. Communicate effectively with patients to ensure the patient is:
- Fully informed about alternative treatment options along with the relative indications, contra-indications, prognoses and costs.
- Fully informed about the advantages and disadvantages of using implant-supported restorations to restore the normal function and appearance of their dentition.
- Sufficiently educated and informed to give valid consent prior to commencement of implant treatment.
- 3. Prescribe and undertake effective and necessary imaging of the mandible and maxilla with appropriate justification and reporting on the images and interpret the image and reports to inform the implant treatment.
- 4. Provide the necessary routine dental care or refer patients appropriately to ensure stabilisation of any dental caries, periodontal disease, endodontic diseases or occlusal issues prior to provision of implant dentistry.
- 5. Provide the necessary complex dental care or refer patients appropriately to ensure that any more significant and/ or higher priority oral health needs are managed appropriately, prior to provision of implant dentistry.
- 6. Establish and operate in a suitable environment and manage dental team members, to ensure appropriate conditions are met for surgical asepsis.
- 7. Safely and effectively raise mucoperiosteal flaps and suturing.

- 8. Safely and appropriately use exogenous bone or bone substitute biological materials for minor dentoalveolar augmentation for socket preservation prior to implant surgery or for augmentation required at the time of implant surgery.
- 9. Prescribe and apply appropriate pharmaceutical agents and medication in an evidence-based and safe manner.
- 10. Diagnose and appropriately manage complications occurring during or after implant treatment
- 11. Monitor and maintain implant-supported restorations and repair or replace any implant or prostheses as and when required.
- 12. Document and audit all clinical activity to an appropriate standard in line with current regulations and guidelines

#### Case submissions

Each delegate will submit 5 Implants cases each and will be asked to present and defend their cases, there will be oral examination about the submitted cases and delegates will be assessed for clinical competency, case presentations and regarding their core knowledge about the performed procedures, rationale of how they have managed the cases.

# **Reflective writing**

Each delegate will be submitting reflective writing of 3000 words on the topic mutually agreed and they will be then assessed on their reflective writings.
